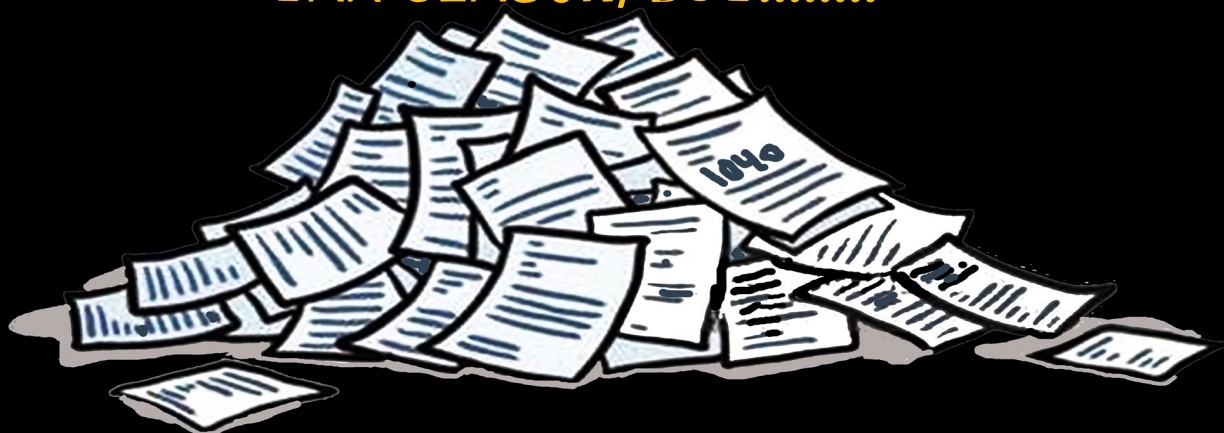

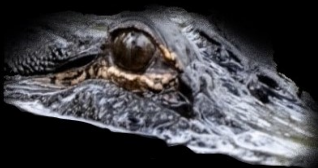




## So, What is an Okefenokee?.....
